MEMORANDUM

I, RYAN J. MACDONALD, am the supervising attorney in the abovecaptioned case. This Court may extend the time to file an Answering Brief upon a showing of good cause. NRAP 31(b)(3)(D); SCR 250(6)(e).

The State's Answering Brief on the instant matter is currently due on June 3, 2017 following SIX extensions of time granted to the Appellant.
