Thank you again, Justin, for your response. We were just informed today by another of the amici seeking to file in support of respondents that they plan to file an amicus brief on April 20. A 14-day extension from our current due date of April 11 would make our reply brief due Monday, April 25—only a few business days after the amici brief was filed. We cannot be sure, especially since we don't know what the amici will say, that we won't be prejudiced by that very short interval.
