11 Pursuant to NRAP 14(f), Respondent Reno Newspapers, Inc., doing business as the
12 Reno Gazette-Journal ("RGJ"), responds as follows to the Docketing Statement filed in this
13 matter by Appellant City of Sparks ("the City"):

14 In response to Docketing Statement Questions 8 (Nature of the action) and 9 (Issues on
15 appeal), the City states that the RGJ requested "the names and personal information" of persons
16 to whom the City issued business licenses to operate medical marijuana establishments. The
17 RGJ strongly **disagrees** with that statement. The RGJ requested copies of "the business
18 licenses of medical marijuana establishments in Sparks, including the names of the
19 applicant/licensees." Beyond the contents of the licenses, including the names of the licensees,
20 the RGJ did not request "personal information" for any person.
