**STIPULATION FOR EXTENSION  
OF TIME TO FILE ANSWERING  
BRIEF ON CROSS APPEAL**

Pursuant to Rule 31(b)(1) and (2) of the Nevada Rules of Appellate  
Procedure, the parties stipulate that the time for filing Cross Respondent Acres

1 Medical LLC's Answering Brief on Cross Appeal may be extended by six days  
2 from its current due date of December 15, 2016. The extension will make the due  
3 date December 21, 2016. Acres Medical LLC's previously obtained a telephonic  
4 extension of fourteen days from the original due date. Accordingly, the new due  
5 date will be twenty days from the original due date, less than the 30 days permitted  
6 under NRAP 31(b)(2).

9 Because of the extension of Acres Medical LLC's Answering Brief, Nuleaf  
10 CLV's combined answering brief on cross-appeal and reply brief on appeal will also  
11 be extended by 6 days, from January 3, 2017 to January 9, 2017. <sup>1</sup> The due date for  
12 GB Science's respective replies shall be 30 days from the filing of each of Acres  
13 and Nuleaf CLV's briefs. However, in the event that GB Science chooses to file  
14 only a single Reply, then the due date shall be 30 days from the date that Nuleaf  
15 CLV's brief is filed.
