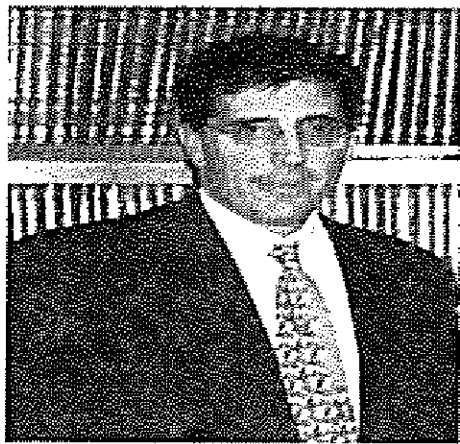

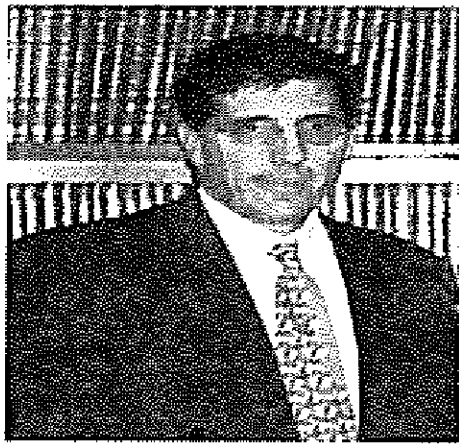

SUPPLEMENTAL REPORT

As you recall, I performed an Independent Medical Evaluation upon Beau Orth on 07/17/2013 and for the results of that Independent Medical Evaluation as far as my opinions, please see that document. I have since been provided with additional documents pertaining to this matter.

First and foremost, I reviewed a 169-page deposition taken of Albert Capanna, M.D. on 01/15/2015. In addition to this deposition where Dr. Capanna states that he did not operate on the wrong level on 09/17/2010 when performing Mr. Orth's surgery, he did admit that he dictated a procedure done at L5-S1 and postoperative scans showed that the surgery was performed at L4-5. Dr. Capanna recognized that he should have dictated that he entered L4-5 and stated that he had to enter above to dissect down to see the L5 nerve root or L5-S1 disc.

In addition to this, I have reviewed additional documents.

12/09/2010 through 09/15/2011 – I have reviewed visits to the Keith Kleven Physical Therapy facility for therapeutic modalities pertaining to his back. Between 12/09/2010 and 09/15/2011, he is seen on five occasions.

02/08/2011 – Andrew Cash, M.D. – A record in which the patient is assessed with a postlaminectomy syndrome and lumbar radiculopathy. Dr. Cash states that he would not recommend football for the remaining of the year of 2011. It is recommended that he continues with physical therapy and follow up for a reevaluation.

03/12/2014 – Cash, M.D. sees the patient. The assessment is postlaminectomy syndrome and lumbar radiculopathy. Dr. Cash recommends an MRI with and without contrast, as well as a Medrol Dosepak as the patient is complaining of back pain with pain radiating into the left leg. Dr. Cash also recommends light duty work restrictions with no lifting greater than 20 pounds and no frequent or constant bending, twisting or stooping at the waist.

03/13/2014 – MRI of the lumbar spine shows postsurgical changes at L4-5 and a minimal disc bulge there and at L5-S1, there is disc desiccation with a stable disc bulge with no critical stenosis.

03/18/2014 – Cash, M.D. sees the patient. The assessment is postlaminectomy syndrome, lumbar radiculopathy, and disc protrusion with annular tear at L5-S1 contacting and displacing the left S1 nerve root. Recommendations are for epidural steroid injections at L5-S1 and to continue with physical therapy. Again, Dr. Cash recommends light duty with no lifting greater than 10 pounds frequently and 20 pounds occasionally.

03/19/2014 – Ruggeroli, M.D. sees the patient. The assessment is lumbar disc herniation or protrusion. Neurontin and amitriptyline are prescribed and it is recommended that the patient undergo left L5-S1 transforaminal epidural steroid injections.

03/26/2014 – Ruggeroli, M.D. performs left-sided L5-S1 transforaminal epidural steroid injections and a left S1 transforaminal epidural steroid injection.

04/10/2014 – Ruggeroli, M.D. sees the patient. The assessment is lumbar spondylosis and facet based pain. Neurontin and amitriptyline are noted to be taken by the patient. The patient is recommended for lower lumbar facet injections and if there is no improvement, consider a spinal cord stimulator placement.

04/16/2014 – Ruggeroli, M.D. performs left-sided L4-5 and L5-S1 facet joint injections.

05/01/2014 – Ruggeroli, M.D. sees the patient. The assessment is lumbar spondylosis and facet based pain. The patient had the injections and had temporary complete relief of his symptoms, but the pain returned and therefore Dr. Ruggeroli recommends left-sided L4-5 and L5-S1 radiofrequency thermal coagulation procedures.

05/14/2014 – Ruggeroli, M.D. performs radiofrequency thermal coagulation at the left medial branch at L3, the left medial branch at L4, and the left L5 dorsal ramus.

06/11/2014 – MRI of the brain is unremarkable.


