- Plaintiffs' expert fees in excess of \$1,500.00 are reasonable and were necessary under the 81. circumstances.
 - a. Plaintiffs needed to retain a financial expert to evaluate PERS' determination of past due benefits because the complexity of the formula used to calculate PERS benefits requires specialized skills.
 - b. Plaintiffs' expert was required to perform an independent analysis in order to verify the accuracy of PERS' calculations. This included reviewing the statutes to identify the formula used to calculate survivor benefits and reviewing PERS' records related to Kristine Freshman's account to identify the individualized values for the calculation.
 - c. Plaintiffs' expert is fully qualified and appropriately credentialed and educated for the tasks performed. A true and correct copy of the curriculum vitae for Kirk Jacobson is included in Exhibit 26.
 - d. Plaintiffs retained only one expert in this matter, and the cost is relatively minor in relation to the damages recovered. As of September 1, 2015, PERS owed Shae more than 5½ years of back payments, totaling approximately \$270,000.00 (\$203,231.76 in back payments, and \$69,340.40 in accrued interest). However, the total amount of damages recovered is far greater because Shae is entitled to lifetime benefits.

- e. The role of Plaintiffs' expert was crucial in resolving the case. As a direct result of Plaintiffs' expert, the Parties were able to avoid further discovery and motion practice and/or a trial on damages and enter into a stipulated judgment.
- f. Plaintiffs' expert charged reasonable hourly fees, appropriately allocated work to an associate charging significantly lower rates, and ultimately discounted the cost of his services by approximately 10%.
- 82. Furthermore, the Parties entered into a series of stipulations designed to minimize the scope and expense of discovery for both Parties. Although both Parties derived significant savings in attorney hours and costs from these stipulations, the agreed upon limits increased the importance of Shae's expert.
 - a. Early in the case, the Parties agreed to bifurcate discovery in an effort to limit each Party's costs, which is reflected in the Joint Case Conference Report. They agreed to a short discovery period (90 days) after which the Parties would file cross-motions for summary judgment. The Parties anticipated reopening discovery if Plaintiffs prevailed on the issue of liability so they could conduct further discovery regarding the amount of damages. Both Parties experienced at least one significant benefit; Plaintiffs did not choose to depose a representative of PERS, saving both parties the expense of preparing and taking a deposition.
 - b. During discovery, Plaintiffs disputed the adequacy of PERS' responses to many of Plaintiffs' written discovery requests. However, the Parties agreed that Plaintiffs would stay their efforts to compel supplemental responses until after the Court ruled on PERS' liability. Thus, both Parties avoided the time and cost associated with the discovery dispute process, supplemental responses, and a motion to compel.
 - c. After the Court ruled in Plaintiffs' favor on summary judgment, the Parties agreed to forgo further discovery in lieu of an informal exchange of information regarding PERS' calculation of damages. PERS agreed to provide Plaintiffs with its calculations regarding the amount of past-due benefits so Plaintiffs experts could

review the calculations. Thus, the Parties avoided the additional costs associated with formal discovery.

- 83. Each of the preceding costs are correct to the best of my knowledge and belief, and the costs were necessarily incurred in this action.
- 84. I declare under penalty of perjury under the laws of the State of Nevada that the foregoing is true and correct.



OBJECTIONS

Defendant objects as follows:

I. Section C. Expert Witnesses

Defendant objects to the expert witness fees for JW Advisors in the amount of \$5,000.00 as the expert witness did not prepare a report, was never sworn and did not testify at trial. *See,* NRS 18.005(5). The total amount objected to by Defendant on Section C is \$5,000.00.

Exhibit 26 of Plaintiffs' Memorandum of Costs contains the support for Plaintiffs' claim for expert witness fess pursuant to NRS 18.005(5). The primary charges are logged by William Hinsdale at \$180 per hour which represents \$4,185 of the requested amount. There is no evidence whatsoever that Mr. Hinsdale could be certified as an expert in the analysis of the PERS formulas for the calculation of benefits.

There is a Curriculum Vitae of Kirk Jacobson who logged 4.50 hours at \$300 per hour. However, Mr. Jacobson's CV provides no information that he could be qualified as an expert in the analysis of the PERS calculation of benefits under NRS Chapter 286. Rather, his expertise appears to be fraud investigations and business disputes, none of which were relevant to this case.

More importantly, neither person was sworn and testified at a trial or even in an affidavit. Neither was disclosed by Plaintiffs as an expert witness. The allowance of costs is for "expert witnesses". The fee is limited to \$1,500 per witness "unless the Court allows a larger fee after determining that the circumstance surrounding the expert's testimony were of such necessity to require the larger fee". [emphasis added] NRS 18.005(5). By its own terms, expert fees are limited to experts who testify. In this case, neither person is qualified as expert and neither person testified. *Mays v. Todaro*, Nev., 626 P.2d 260, 263 (1981) (Expert witness fees can be awarded "if the witness had been sworn and testified".) *See, Maxwell v. Amaral*, 79 Nev. 323, 383 P.2d 365, 368 (1963) (Expert provided written report, but did not testify to fees were not awarded.).
