

LINDA MARQUI DISTRICT JUDGE FAMILY DIVISION, DEPT LAS VEGAS, NV 8910 The Court made an evidentiary ruling regarding audio recordings. Counsel for Ms. Abid argued that the audio recordings should not be admitted into evidence and, in fact, the audio recordings and/or transcripts were never admitted into evidence. However, the Court allowed Plaintiff's expert, Dr. Stephanie Holland, to review the audio tapes and/or transcripts of the audio tapes, along with other things that were not admitted into evidence, prior to her interviews of the Parties and the Parties' minor child.

The Court did not delay the hearing of this matter. Ms. Abid's Counsel
requested a continuance of the Evidentiary Hearing, which was granted. See
Defendant's Motion to Continue Evidentiary Hearing, filed July 31, 2015. Later,
Counsel for both Parties stipulated to continue the Evidentiary Hearing. See
Stipulation and Order dated October 1, 2015.

On December 07, 2017, the Nevada Supreme Court issued a unanimous Advanced Opinion in this matter affirming this Court's orders. The Nevada Supreme Court stated that this Court's factual findings in this matter were support its determination as to the child's best interest. Therefore, this Court did not abuse its discretion in providing recording to the expert as it aided the Court in its determination as to the child's best interest.
