

MOTION FOR EXTENSION OF TIME TO FILE REPLY BRIEF

Appellant Michael Foley requests an extension through February 20, 2018 to file his reply brief. *See* NRAP 31(b)(3). This is the second such request. The brief was originally due December 13, 2017 and is now due January 16, 2018.

Additional time is necessary. First, Mr. Smith, the *pro bono* attorney primarily responsible for drafting the reply brief unexpectedly had to take time to assist some family friends who were suddenly rendered homeless with their infant son due to circumstances outside of their control. Third, Mr. Polsenberg has also had to dedicate significant time to preparing for and arguing the writ petition in *Wynn v. District Court*, Case No. 74184—his third oral argument before this Court in a month—which prevented him from assisting Mr. Smith in the preparation of this reply.
