MOTION FOR EXTENSION OF TIME TO FILE <u>PETITION FOR LIMITED REHEARING</u>

Appellant Michael Foley requests a 32-day extension, through March 11, 2019, to file a petition for rehearing. *See* NRAP 31(b)(3), 40(a)(1). This is the second request. The first was granted in full. Without the extension, the petition would be due February 7, 2019.

Although the petition is nearly complete, the requested extension is necessary. The wife of appellant's *pro bono* counsel recently underwent surgery, the recovery from which has taken longer than expected and has required counsel to take time away from the preparation of this petition. In addition, the absence of an answering brief or oral argument has made it somewhat challenging in some instances to determine the basis for the Court's decision. We have narrowed the scope of our request for rehearing but need additional time to make clear how the court misapprehended the presentation of those limited issues in the briefs. And while counsel's caseload is not in itself a reason for an extension, we have several other *pro bono* matters, including two others before this Court in which briefs are coming due and which have required significant attention.

We appreciate the Court's courtesy and anticipate filing the petition within the requested deadline.
