**MOTION FOR EXTENSION OF TIME TO FILE
REPLY BRIEF ON REHEARING**

Appellant Michael Foley requests a 30-day extension, through July 11, 2019, to file his reply brief on rehearing. *See* NRAP 31(b)(3). This is the first such request. Without the extension, the reply would be due June 11, 2019.

Michael's *pro bono* counsel have devoted extensive resources to preparing the reply but need additional time to coordinate with Michael and to streamline the arguments. The state's amicus brief raises several new factual contentions not substantiated in the appellate record, and the state appears at points to challenge this Court's resolution of the appeal, even though neither respondent Patricia Foley nor the state requested rehearing. The extension will enable Michael's counsel to

address these issues (or to determine which peripheral matters can be left unaddressed).
