**MOTION FOR EXTENSION OF TIME TO FILE
REPLY BRIEF ON REHEARING**

Appellant Michael Foley requests a 14-day extension, through July 25, 2019, to file his reply brief on rehearing. *See* NRAP 31(b)(3). This is the second such request. The reply was originally due June 11 and, without the extension, would be due July 11, 2019.

Michael's *pro bono* counsel have worked diligently on the brief, which is nearly complete for filing. Unfortunately, co-counsel Joel Henriod recently suffered a serious injury: He broke three of his fingers last week, culminating in surgery two days ago. He remains in pain that is controlled only by prescription drugs not compatible with the practice of law. While Mr. Henriod did not directly participate in the preparation of this brief, his sudden absence has required Mr. Smith and Mr. Pol-

senberg to divert their resources to other cases with immovable deadlines. This short extension will give Mr. Foley an opportunity to weigh in on the brief and greatly help counsel ease the scheduling problems precipitated by this emergency.
