Respondent, BARBARA CEGAVSKE, Nevada Secretary of State (“Secretary”), through Attorney General Adam Paul Laxalt and Senior Deputy Attorney General Lori M. Story, hereby provides this Honorable Court with Notice of her intent not to file an answering brief in this appeal.

The Secretary is named as a respondent in her capacity as the chief officer of elections for the State of Nevada charged with the execution and enforcement of the provision of Title 24 of the Nevada Revised Statutes and all other provision of state and federal law relating to elections and initiative petitions in the state. The
