

12 transcript requests which has delayed the completion of these transcripts.

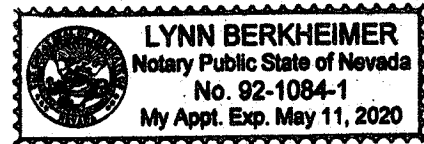
13 3. That this request has been sent out to an outside transcriber and at the request


