MOTION FOR EXTENSION OF TIME TO FILE OPENING BRIEF

Appellants First Transit, Inc. and Jay Farrales request an additional five judicial days, through October 30, 2017, to file their opening brief. NRAP 31(b)(3). This is the third request. The brief was originally due August 21, 2017, and the second extension continued the deadline until October 20, 2017. No requests for extension have been denied or denied in part.

The brief is essentially complete. And appellants expected to file it today (just as they filed 11 volumes of the appendix). The electronic document, however, appears to be corrupted. For example, citations that had been clear are jumbled. Every effort to generate a table of contents and a table of authorities is not only ineffective, it also seems to disrupt the body of the brief.

While it is possible that the underlying problem(s) might be identified and fixed by the end of the next business day (Monday, October 23),

undersigned counsel is not confident of that. Time will be needed to ensure that the citations to over 120 legal authorities (not including short-form citations) are still accurate, to verify that all previous edits and revisions are included, and to check the hundreds of references to the record in 83 pages. Therefore, to be cautious, appellants request an additional five judicial days to complete and file this important brief.
