**MOTION FOR EXTENSION OF TIME TO FILE  
ANSWER TO PETITION FOR REHEARING**

Appellants First Transit, Inc. and Jay Farrales request an extension of 30 days, through December 26, 2019, to file their answer to the petition for rehearing. NRAP 31(b)(3). This is the second such request. The answer was originally due October 24, 2019 and, without an extension, would be due November 25, 2019.

Additional time is needed for a few reasons. First, a rather severe flu or cold virus has been making its way around the office of appellants' counsel. Several people who were (or could have been) working on this brief were out for multiple days. Secondly, undersigned counsel has been drawn away over the last two weeks opposing an unforeseeable motion for preliminary injunction in federal court regarding a signif-
