**MOTION FOR EXTENSION OF TIME TO FILE
ANSWER TO PETITION FOR REHEARING**

Appellants First Transit, Inc. and Jay Farrales request an extension of two weeks, through January 9, 2020, to file their answer to the petition for rehearing. NRAP 31(b)(3). This is the third such request. The answer was originally due October 24, 2019 and, without an extension, would be due December 26, 2019.

The need for this additional time arises from an unforeseeable and serious family emergency. Undersigned counsel (Joel Henriod) had been drafting the answer to the petition for rehearing. Although he was splitting his time between completing this answer and participating in a four-week trial, the deadline of December 26 was practicable. On December 10, his elderly mother fell and injured herself, which required

ongoing attention to assist her and coordinate care. Mr. Henriod still continued to complete the answer. Then, during the week of December 16, his father became ill and bedridden. The confluence of those events, especially during the holiday season, multiplied the time required to manage his parents' affairs.

Other attorneys were enlisted to help complete the answer as soon as it became clear that Mr. Henriod would not be able do so alone. Completion by December 26 is not feasible, however. Appellants therefore request an additional two weeks in which to complete and file their answer to Respondent's petition for rehearing.
