MOTION FOR EXTENSION TO FILE PETITION FOR REHEARING

Appellants request to extend the deadline for filing a petition for rehearing by 14 days, up to and including October 27, 2020. NRAP 31(b)(3). The petition was originally due September 29, 2020 and is currently due October 13, 2020. This is the first motion for extension under NRAP 26(b)(1)(A). (Appellants previously obtained a 14-day telephonic extension pursuant to NRAP 26(b)(1)(B), which they believed would be sufficient.) No request for additional time has been denied or denied in part.

The petition is nearly complete but extraordinary circumstances have delayed completion, particularly the combination of an

extraordinarily busy caseload colliding with an unforeseeable illness and a family emergency. Over the last 30 days, appellants' counsel collectively have handled nearly a dozen substantial hearings in addition to two appellate oral arguments, and have filed several significant briefs. While that alone would not have precluded completion of the petition, their schedule was compacted further by health issues requiring multiple medical appointments and an urgent family matter.

Appellants believe this request is reasonable under the circumstances, as well as proportional to the two extensions that plaintiffs procured to prepare their petition for rehearing, a 14-day telephonic extension (doc. 19-33611) followed by a 30-day extension, which appellants did not oppose (doc. 19-36166). Undersigned counsel are sensitive to the length of these proceedings and have no intention to hinder or delay.

Appellants, therefore, move for an extension of time of 14 days of the deadline to file the petition for rehearing. Counsel appreciates this Court's courtesy in considering this extension.
