## ORDER CONDITIONALLY IMPOSING SANCTIONS

This appeal was docketed in this court on April 21, 2016. Because the notice of appeal was not accompanied by the case appeal statement and the rough draft transcript request form, on April 21, 2016, this court sent appellant's counsel, John P. Parris, notices to file the case appeal statement and the rough draft transcript request form within 10 days or face sanctions. See NRAP 3(f)(1); NRAP 3C(d)(3)(ii); NRAP 3C(n). Further, the fast track statement and appendix were due to be filed no later than May 31, 2016. NRAP 3C(e). To date, Mr. Parris has failed to file the case appeal statement, rough draft transcript request form, and the fast track statement and appendix.

We conclude that Mr. Parris's failure to file the required documents warrants the *conditional* imposition of sanctions. See id. Within 15 days from the date of this order, Mr. Parris shall pay the sum of \$250 to the Supreme Court Law Library and provide this court with proof of such payment. Mr. Parris shall have 11 days from the date of this order to file and serve in this court the case appeal statement, 2 file-stamped

copies of the rough draft transcript request form and proof of service of the rough draft transcript request form, and the fast track statement and appendix, or a motion to extend time. See NRAP 3(f); NRAP 3C(d)(3); NRAP 3C(i)(2)(B). If the required documents are timely filed, the conditional sanction will be automatically vacated. If the required documents are not timely filed, the sanction will no longer be conditional and must be paid.

Failure to comply with this order or any other filing deadlines will result in the removal of Mr. Parris as counsel of record in this appeal. See NRAP 3C(n). Further, because it appears that Mr. Parris's conduct in this appeal may constitute violations of RPC 1.3 (diligence), 3.2(a) (expediting litigation), and 8.4 (misconduct), failure to comply with this order or any other filing deadlines will also result in Mr. Parris's referral to the State Bar of Nevada for investigation pursuant to SCR 104-105.

It is so ORDERED.
