MOTION FOR PERMISSION TO WITHDRAW AS COUNSEL

Mark Wray moves this Honorable Court for an order permitting his withdrawal as counsel for Appellant MEI-GSR Holdings, LLC d/b/a Grand Sierra Resort (“Grand Sierra”) and removing him from the certificate of service.

Granting this motion will have no effect on this appeal, in that Wray is not providing any legal services to the Grand Sierra on this appeal.

Wray served as local counsel for Grand Sierra at the trial court level. Wray filed an Association of Counsel on November 3, 2014. Wray has performed very limited services in this action since that date.

Since the conclusion of the trial, there have been post-trial motions in the district court. Wray has had no involvement in the post-trial motions nor the instant appeal. Wray’s name does not appear on the Docketing Statement, filed May 25, 2016, nor does

1 it appear on the Certificate of Service, filed May 31, 2016. He is not counsel on the
2 appeal.

3 The Grand Sierra has been represented by the law firm of Cohen Johnson Parker
4 Edwards and other counsel, and those attorneys continue their representation through this
5 appeal. Wray's withdrawal from this case will not harm or prejudice the Grand Sierra in
6 any way.

7 In accordance with NRAP 46, Mark Wray respectfully requests that this
8 Honorable Court enter its order granting his withdrawal in this matter.
