DECLARATION OF SHARON G. DICKINSON

- 1. I am an attorney licensed to practice law in the State of Nevada; I am a deputy public defender assigned to handle the appeal of this matter; I am familiar with the procedural history of this case.
- 2. John Morgan filed a Notice of Appeal in this matter on 05/17/16. At the time of the filing of the notice, this case was governed by the provisions of NRAP 3C, which required Appellant to file a Fast Track Statement. On 09/29/16, Court granted full briefing making the Opening Brief due on 10/31/16. Thereafter, Morgan asked for continuances due to missing portions of the transcript, making the Opening Brief due today.
- 3. On or about 12/12/16, I obtained the final missing portions of the transcripts. This week, our clerk placed them in the appendix. While working on the appeal and going through the appendix this week I realized the competency evaluations were not included. Because I intended to refer to the competency evaluations which are sealed documents and because I did not have a copy of all of them until today, I need additional time to review them for incorporation into the argument. Also, today, I realized that although I obtained the jury selection documents from the clerk's office evidence vault, I had not yet sought to make them officially made part of the record. I contacted the DA in this case and asked her for a stipulation regarding the documents and she has not yet made a decision. Thus, I need additional time to obtain the order. I am
