**STIPULATION FOR EXTENSION OF TIME TO FILE OPENING BRIEF AND
AMEND BRIEFING SCHEDULE REGARDING CERTIFIED QUESTION OF
LAW**

Respondent, UNITED AUTOMOBILE INSURANCE COMPANY and Appellants, JAMES NALDER, GUARDIAN AD LITEM ON BEHALF OF CHEYANNE NALDER and GARY LEWIS, INDIVIDUALLY, hereby stipulate to extend the time for Appellants to file their Opening Brief, Respondents to file their Response Brief and, for Appellants' to file their Reply brief Regarding Certified Question of Law from the United States Ninth Circuit Court of Appeals by forty-nine (49) days.

The reason for this extension is due to Respondent's new counsel in this matter. This Court granted Thomas Scott and Scott Cole's Motion to Associate on

September 7, 2016. Further, the parties are seeking to conduct a private mediation.
