**STIPULATION FOR EXTENSION OF TIME TO FILE REPLY BRIEF  
REGARDING CERTIFIED QUESTION OF LAW**

Appellants JAMES NALDER, GUARDIAN AD LITEM ON BEHALF OF CHEYANNE NALDER and GARY LEWIS, INDIVIDUALLY, and Respondent, UNITED AUTOMOBILE INSURANCE COMPANY, hereby stipulate to extend the time for Appellants to file their Reply Brief regarding the certified question of law by fourteen (14) days up to and including, February 16, 2017. On August 15, 2016, this Court approved the parties' stipulation to extend time for Appellants to file their Opening Brief by thirty (30) days. On September 30, 2016, this Court approved the parties' stipulation to extend the time to file opening brief and to amend the briefing schedule by forty-nine (49) days. Appellants have not sought any other prior extensions of time and this Court has not denied any requests for

extensions of time to file any pleading. Appellants' Reply Brief is currently due on February 2, 2017.

Orth*, Case No. 69935, due to this Court on January 31, 2017. This short extension will ensure that Appellants can evaluate all of the arguments contained in Respondent's Brief as well as the Amici Curae Brief to prepare a comprehensive reply brief regarding the significant question of law before this Court.

Further, this request is not meant to prejudice Respondent or cause undue delay.
