**MOTION FOR EXTENSION OF TIME TO FILE SUPPLEMENTAL OPENING
BRIEF REGARDING SECOND CERTIFIED QUESTION OF LAW**

Appellants JAMES NALDER, Guardian Ad Litem on behalf of CHEYANNE NALDER and GARY LEWIS, individually respectfully request an extension of thirty (30) days, up to and including August 1, 2018, to file their Supplemental Opening Brief Regarding Second Certified Question of Law. This is the second such motion Appellants have filed. On March 22, 2018, the parties filed their first Stipulation for Extension of Time to File Supplemental Opening Brief Regarding Second Certified Question of Law pursuant to NRAP 31(b)(2). On May 24, 2018, this Court granted Appellants' first Motion for Extension of Time. This Court has not denied or denied, in part, any requests for extensions of time in this case. Appellants' Supplemental Opening Brief Regarding Second

Certified Question of Law is currently due on July 2, 2018.

Appellants request this Court to allow additional time to complete their Supplemental Opening Brief. 
