## ORDER

Cause appearing, the unopposed motion filed by Nevada Attorneys for Criminal Justice for leave to file an untimely brief of amicus curiae in support of real party in interest Dontae Hudson is granted. NRAP 29(f); Ryan v. Commodity Futures Trading Comm'n, 125 F.3d 1062, 1063 (7th Cir. 1997) (an amicus brief is generally appropriate where "the amicus has unique information or perspective that can help the court beyond the help that the lawyers for the parties are able to provide").

We are unable to file the submitted brief at this time however, because the brief does not contain a table of contents as required by NRAP 28(a)(2), and does not contain a certificate of compliance as required by

NRAP 32(a)(9).¹ Because the brief is not prepared in accordance with the rules, we direct the clerk of this court to reject the amicus brief attached to the motion filed via E-Flex on February 17, 2017, and the corrected amicus brief attached to the motion filed via E-Flex on February 19, 2017. See NRAP 32(e) ("If a brief . . . is not prepared in accordance with [Rule 32], the clerk will not file the document, but shall return it to be properly prepared."). Nevada Attorneys for Criminal Justice shall have 7 days from the date of this order to file and serve an amicus brief that complies with NRAP 28 and 32. Petitioner shall have 15 days from the date of service of the amicus brief to file and serve any response.

It is so ORDERED.
