



2. On June 14, 2016, I received a Request for Transcripts.

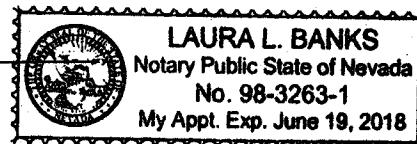
