And who told you to talk to the counselor? 21 Q 22 Xylie and Meagan. 23 Ms. McNeill also asked you if you'd heard about other people or other kids being raped and people being taken 24

out of the home and stuff; right?

1 Α Yes. About Raven, did you know any details of what 2 Q Okay. happened or how she was raped? Not really. 4 Α 5 What do you mean by not really? DIRECT EXAMINATION

BY MS. JOBE:

- Q Good afternoon. What is your occupation?
- A I'm a pediatrician at a couple locations here in Las Vegas. I work out of Southern Nevada Children's Assessment Center, otherwise known as the SNCAC, as well as Sunrise Children's Hospital. At both facilitates I work as a pediatrician that evaluates concerns of child abuse and/or neglect, both sexual abuse and/or physical abuse. And then I additionally work part time as an emergency room physician at Sunrise Children's Hospital's Pediatric Emergency Department.
 - Q What is your training and experience?
- A So I earned a Bachelors of Neuroscience at UCLA, after which I went to University of Vermont for my medical degree. Once that was complete I was a medical doctor, but then continued on to a specialty residency in pediatrics at the University of Nevada here in the Las Vegas program. After graduation I attended an apprenticeship in child abuse pediatrics with a child abuse pediatrician here in town. And then I additionally attend several conferences on a yearly basis both in general pediatrics and child abuse pediatrics.
- Q Fair to say you attend conferences and maintain your specialty in pediatrics and abuse and neglect over the years?
- 24 A Yes.
 - Q Okay. For patients you see at the Southern Nevada

Children's Assessment Center how do those patients come to your attention?

A So I have a -- it's an outpatient clinic that we run Mondays and Thursdays. They are by referral only through one of the outside agencies, either Child Protective Services or law enforcement.

Q When you do a -- when you receive a patient through SNCAC do you have a standard procedure or protocol you go through with that child? Do you even do a medical exam?

A Yes. We -- do you want me to go through the kind of procedure?

Q Yeah. What the procedure of the exam?

A So basically -- so each appointment lasts about an hour to an hour and a half. I have two nurses. Sometimes we have one or two nurses, based on the day they come in. When the child comes in first we get medical information, we triage them, which just means their height, weight, vital signs, heart rate, that kind of stuff. Just a normal doctor's office. We do a visual acuity, so we have them stand and look at an eye chart, make sure that they're able to see well. We check their teeth briefly, also, if we have to refer anyone out to any kind of other specialty services.

After that sometimes I talk to the patients privately to obtain more medical history, and it just kind of depends on the patient. After that the nurses will explain

the entire exam to any of our patients that we have in an ageappropriate way with their clothing on before they get into a
gown or anything like that. We explain everything so there
are no secrets at clinic.

After that we complete the medical examination, and then oftentimes I will talk to a parent afterwards and explain any findings or any relevant information, and answer their questions.

Q Now, specific to patients you receive regarding disclosures of sexual abuse is the -- are the details or the nature of their disclosure important to your exam and what you're looking for?

A Yeah, the type of contact they report or any kind of contact that they may have had will a lot of times guide what kind of testing we do, if we have to do bloodwork or cultures or anything additional.

Q And when you are doing an assessment on a female patient who has reported sexual contact do you find out their history as far as their cycle or when they started their cycle?

A Yes.

- Q And why would you do that?
- A Again, you know, first and foremost we're looking for patient health. And so if a young lady has not started her period and she's an age that we would expect her to or

they've started early or they're right on time, we deal with any kind of referrals that they may need or any kind of health -- I guess health matters that surround that.

Q Now, these patients that you receive at the SNCAC, do you continue to see them, or is it kind of a one-time assessment and then send them on their way?

A It's usually a one-time assessment. If they are -come back positive for some kind of infection, they return to
the clinic for management and then also for a followup
examination. If there's an injury or something that needs to
be followed, we will do a short followup just to make sure
that any infections that we've treated are cured, and then we
refer them out to their regular either pediatricians,
gynecologists, whomever they need to go see.

Q During the course of being a physician and being in a position at the SNCAC approximately how many exams have you done on sex abuse victims?

A It would be in the thousands at this point.

Q And overall generally speaking of the thousands of exams that you've done is there kind of a frequency of what you would consider normal physical findings versus abnormal physical findings?

A Sure. So the classifications that are kind of made when we look at anybody, they follow a normal variation, normal exam, maybe a nonspecific exam, something that maybe

it's abnormal, maybe it's not, but we can see that in both cases. They are concerning findings, and then they are going to be definitive findings for some kind of forced injury. And about 95 percent or about 90 percent of the exams are normal.

Q And what types of things may determine whether you would have -- you said sometimes there are findings of forced physical interaction or not. What types of things would determine whether you may see them or may not?

A Well, at the SNCAC we see only non-emergent cases. So one part of that is that enough time has gone by, we're collecting evidence let's say in an emergency room a rape kit, that kind of thing, that's not something that's relevant to this patient and they've disclosed that something inappropriate may have happened but some time has passed so -- a week or two weeks, more than that. So one part of -- one feature of why a lot of exams are normal are, one, because if there were any injuries they would have healed by the time we've seen them, and the body, both female and male, tend to heal very well especially in the genital area that scar tissue or anything like that may not be present.

And then another factor is that especially with children when it comes to sex abuse what is found in research and experience is that a lot of times they know the person that has abused them, a lot of times that person has spent time what we say is grooming them or making any kind of sexual

contact more acceptable, so they may not injure that child to either continue having access to them or for other reasons.

Q As far as you indicated there may be healing of the genital area before -- even if there's scar tissue before the patient comes to the SNCAC. How does that apply to the anus or the buttocks area?

A The same as it would with the genitals. And in fact with the anus it's an area that's supposed to be stretchy, and people get constipated, have large bowel movements, things like that, and we don't see any injuries or scars. Similarly, even if anything enters or penetrates that area, a lot of times there isn't injury. And injuries that happen don't leave very pronounced scars, so it's sometimes impossible to tell if there has been any kind of injury previously.

- Q On January 23rd, 2013, were you referred a patient by the name of Heather Haney with the date of birth of 6/22/01?
 - A Yes.

- Q And was that referral through CPS or law enforcement?
 - A I believe through both.
 - Q Okay. And you saw her at the SNCAC; correct?
- 23 A That's correct.
 - Q Did you -- the process you've gone through with the assessment and the patient history and the triage, was all

- that done with Heather Haney?
- 2 A Yes.

- Q Okay. During the course of your contact with Heather did you also do a genital exam?
- A Yes, I did.
 - Q Okay. And what was the reason for the genital exam?
- A So any patient that comes, again, to the SNCAC there are concerns usually of some kind of sexual abuse involving the genitals, and so it was for her overall health evaluation.
- Q All right. And I apologize. I might have missated it. But did you see her actually in January of 2014?
- A Oh. It really was 2014. Yes. Sorry.
- Q Okay. I apologize. And when you were doing this exam did you find out the onset of the victim's menses or menstrual cycle?
- A Yes. I think she was -- I think it was back a year previous -- or, no. Sometime in December, maybe a few months prior to seeing us.
 - Q Okay. So fair to say December 2013?
- 20 A Yes.
- 21 Q All right. And when you did your examination of the 22 patient did you find -- were there any abnormal findings?
 - A Nothing overtly abnormal, no.
- Q Okay. When you say overtly abnormal what do you mean?

A She had some normal variations, so things that you see that aren't typical of everyone but can be completely normal.

Q Okay. When you did your examination of this victim it appears from your notes that there was a notch in her hymenal tissue.

A Yes.

Q Okay. And is that a normal variation, or is that something concerning?

Yeah. I mean, by and large -- so I guess to talk about kind of the anatomy, so the hymenal tissue is skin that surrounds the opening of the vagina. It's just skin. It can be stretchy. It's not -- there's a hole in it already. There's nothing -- it's not like a barrier or anything like When we look at the skin that's around the vagina, so that. the hymen, a lot of times it's just smooth and circular, but just like our ears are different, you know, noses, eyes, things like that have different, you know, positions and features, also the hymen can, too. And so we look at the hymen as a clock face, and then at some point you can have little notches or divots in and out of it. If there is actual tissue that's completely missing, that would be abnormal. her case, in this patient's case she had a notch at a place that could it be considered, you know, a possibility from an injury at some point, yeah, it's possible, but it could also

be a normal variation.

- Q Would that be consistent with or inconsistent with the disclosure that there was never any vaginal penetration?
 - A Consistent.
- Q You also during the course of the genital had the opportunity to examine -- or your process is to also examine the anus; is that correct?
 - A That's correct.
- Q Were there any findings or irregularities in that regard?
- She had some findings. So around the anus we have a Α pretty thick vein. That people is where people will get hemorrhoids and those kinds of things. If someone's laying on their back, as do with the types of exams that we have, sometimes that vein around the anus fills with blood and it just -- it pools. And sometimes examiners can look at that quickly and think there may be a bruise or some kind of injury there. And so what we have our patients do is sit up or move around a little bit and do a couple of techniques, and if that blood goes away, then we know it's just a vein that's filling And that's what we saw in her case. with blood. She had a lot of purple around the anus. We had her get up, move, do some things, and then it went away. So it was all normal.
- Q So you talked about the patient being on their back during this examination.

A Yeah.

Q You also said that your nurses go through the procedure on what the patients are going to have happen during the exam before they get in the gown; correct?

A That is correct.

Q Can you just describe what the patient's position is and how I guess invasive or noninvasive the procedure is.

Yeah, sure. So kids who have just kind of started Α puberty or younger tends to be a fairly -- or a noninvasive We have them laying on their back on an exam table. usually use stirrups or some kind of leg holders so that they can move their legs out of the way for me to exam them. that point I will exam the vaginal tissue, look at the stage of puberty that they're in based on pubic hair, based on kind of how the skin looks down on the genitals. I will then move and manipulate the skin. Sometimes I'll position it so that I can see the urethra, where we pee from, the vaginal opening, a and I'll move the skin around the buttocks to see the anus better, after which I will use cotton swabs to take samples both from the anus and from the vaginal tissue or the hymenal tissue, kind of just around that area, to test for chlamydia and gonorrhea, and then that's usually the conclusion of the exam.

They will then get dressed and then have bloodwork if they need it. The bloodwork's for HIV, syphyllis, and

hepatitis.

Q You talked about -- and I might be misstating the medical terms. We talked about the maturity or lack of maturity of the genitalia. Is that fair?

A Yes.

Q Okay. And what -- did you make a determination on this patient, Heather Haney?

A Yes. So puberty stages happen over -- we stage them in five different stages. Stage 1 is baby until, you know, a few months before puberty kind of starts. And then somebody will -- both boys and girls will start getting some pubic hairs, maybe some underarm hairs. That at Stage 2. At Stage 3 there's more hair and at 4 the hair pretty much covers the genitals. Stage 5 it starts looking like an adult stage, that is the adult stage, and the pubic hair starts going down the legs, as well. So she was at a puberty stage of about 4.

Q All right. Now, during the examinations of female patients do you sometimes use a speculum?

A I do sometimes, yes.

Q And what is a speculum?

A So a speculum is what's used in gynelogical examinations to be able to see the inside of the vaginal opening or inside of the vaginal canal, as well as the back of the vagina, where something called the cervix is. It is a plastic piece that kind of looks like a duck bill, I guess,

and then it's inserted in the vagina, opened up, and a light is shined through so that we can kind of see the tissues on the inside better.

Q Based on this -- well, you did a report and marked your findings; is that fair?

A Yes.

Q And in this report it's indicated that you did not use a speculum. Is there a reason why that decision was made?

A Yes. Because of her age and her discomfort with the examination, we didn't think it was appropriate to use for her.

Q What do you mean by discomfort with the examination?

A She was a bit nervous, and it was just not a -- I didn't of her age and stage in puberty that making the exam more invasive would have benefitted her. And we often do that if this is the first time they're getting a gynelogical exam. If a speculum exam is not necessary, then we'd rather defer.

Q All right. And at the time you saw Heather she was 12 years old; is that correct?

A That's correct.

Q Okay. After you've done all your assessments, examined her, found out about the triage and the information received from the nurses did you make any findings as far as whether the exam was normal, if there were nonspecific findings or concerns?

A It was a normal exam. The concern was her disclosure and what she indicated both to our medical staff, as well as to I believe law enforcement in discussing her -- you know, the concerns of sexual abuse.

Q Okay. And I believe you previously testified about 95 percent of the exams you do are normal.

A About 90, 95, yeah.

Q Okay. And is normal -- when you have a normal exam can you tell -- does that tell you anything -- strike that.

That's a bad way to phrase the question.

Fair to say based on looking at the medical -- or doing the medical exam and your findings of being normal fair to say as a medical profession you can't say if that's consistent or inconsistent with what was discussed?

A Correct.

MS. JOBE: Thank you, Doctor.

THE COURT: Counsel.

could just say, this is what she looked like at that time. So I think that got kind of close to the line of what my concern was. But I didn't object to this, and Mr. Langford may be able to say I was ineffective for this, but the reason I did not say anything about this at the time it happened is I didn't want to call more attention to it. But when Ms. Coon was looking at the photos, after she looked at the photos she said under her breath, "She was so cute." That was exactly my concern with these photos coming in in front of the jury.

MS. JOBE: And, Your Honor, as far as the EAster egg hunt thing is concerned, when I showed her that photograph when she identified what the photograph was from she said Easter egg hunt. And the reason I asked the question was simply to establish -- I was trying to draw -- I didn't want any religious ties to it, that's why I said it was just a community event to try to minimize that and to not leave it as it stood with what she said. That was my only intent. That's why I asked that question after she had said it. Had she not said it, I never would have mentioned anything about it.

MS. McNEILL: My bigger concern is the comment that she made. And I heard it, I saw it. Granted, I was watching her very carefully because I was concerned about what may come out of her mouth with the pictures. If any of the jurors saw it, that's clearly inflammatory. Again, it preys on their emotions. That's why I made the objection to those photos.

So I would move for a mistrial at this time based on that coming out in front of the jury.

THE COURT: Okay. Your motion for mistrial is denied. The jury is going to see the photograph. They're going to know that it is some sort of a springtime event. I don't think that saying it's an Easter egg hunt is going to prey on any emotions, I mean, that way. I mean, kids go on Easter egg hunts. She's a grandmother. She said, she's so cute, or she muttered it. But I don't -- I don't want to highlight it. But she shouldn't -- she was toeing the line. I don't fault the D.A.'s Office for that.

MS. McNEILL: I don't fault them for that, either.

I mean, I don't imagine they would have sought to have her say something like that at all. I don't -- I'm not suggesting anything improper on their part.

THE COURT: Right.

MS. McNEILL: It's just it happened.

MS. JOBE: And if I could just make a record, because this is likely to be an issue if this goes up.

Obviously I only asked her to identify who was in the photograph. I didn't ask or try to elicit anything positive, negative, sympathetic, unsympathetic about the fact that it was Heather in the photograph. What she did say -- my recollection was that she said, "That was my Heather." I didn't hear the "cute" part. It was muttered and under her

breath and not directly into the microphone. I specifically avoided following up or asking any questions about that. And, I mean, she is grandmother of this child. There is foundation that she raised the child from birth to eight years old. So I 5 don't think a grandmother's affection or love for the granddaughter necessarily prejudices or preys on the 6 sympathies of jurors. They see it for what it is, is that she's a relative and issue is the victim. MS. McNEILL: -- that happened during the testimony of Ms. Thunstrom. She -- during her testimony she made the statement about Heather telling her that Mr. Langford had tried to break her mother's arm. I objected. That was something that we specifically agreed would not be gone into. I'm going to make another motion for a mistrial. This is the third or fourth incident where something has come up that should not have come up. We had that he was on medication, we had these threats. And, yes, we've dealt with it. But these things still come out, and you can't unring a bell. we have this thing about breaking the arm that we specifically agreed would not be gone into. They were aware that that was in the statement. They could have admonished her not to talk about that. It came out.

And this is a case where we're walking a very fine line. Mr. Langford and I, you know, we agreed that some of these were res gestae and that they would come in and that it would be disingenuous of us to disagree with that when we were going to be bringing some of these in. But we're getting into

this point where there's all of these things coming out in front of the jury that shouldn't be coming out. And I think it's reaching the point where how can we fix it, how do we come back from that.

So I would renew my motion for a mistrial based on the multiple times that things have come in inadvertently that shouldn't have come in.

MS. JOBE: And, Your Honor, as far as the statement about the broken arm, again, I've represented at the bench that we've admonished each and every witness not to bring up bi-polar and not to bring up the child saying that the defendant almost broke the mother's arm. We do our best to [inaudible]. Mr. Burton asked a specific question about physical abuse regarding Heather, and the witness offered that even though it was related to the mother. And so it wasn't intentionally elicited from the STate. We did our best and due diligence to admonish them not to say it.

As far as its effect on the jury, Your Honor, it didn't come up that he'd actually broken her arm. There was testimony earlier from Shay which the defense -- and I'm not saying they were in support of what she said, obviously. That's why we're having this discussion. But this jury has heard that the defendant was abuseive toward Shay Coon. I don't think it's done anything more or less than what they've already heard earlier today.

As far as the statements by the grandmother, we've already addressed those. The State cleaned them up by leading the grandmother through the threats that were actually demands that Heather go live with them and that he didn't make any actual threats to -- that something would happen if she didn't follow his demands.

And as far as the other incident, which is when Shay mentioned he started take medication, I believe that was her misunderstanding. She avoided the word bi-polar. We did our best again. We admonished her multiple times not to say that. We didn't try to elicit that. So we are doing our best to navigate these things through leading questions. I don't believe the jury has been tainted to the point of being beyond coming back or even being anything more than where the evidence lies at this point in time. They asked plenty of questions when it comes to Heather, plenty of questions that challenge her testimony and the details and the fact. And based on everything that's happened so far, that seems to be where the jurors' focus is.

MS. McNEILL: And all of those questions were during Heather. These things have come out subsequent to Heather. Again, I think, you know, the STate is suggesting that Heather was so afraid of my client. And now it makes it sound like the mother is terrified. And that's why I kind of cut the questioning off about that she thought that -- she didn't

believe Heather, because I didn't want them to be making any sort of accusation. Now it's almost like we have this the mother is terrified and that's why she didn't do anything and that -- I mean, the breaking the arm, I think one incident. BUt it's multiple incidents, and it just keeps building to the point where how do we recover from that. And it puts us in a very difficult position where we may have to start trying to address some of these things that we would have never gone into because it's out there.

THE COURT: Okay. Counsel, your motion for mistrial is denied. However, I am concerned. I don't think that the District Attorney's Office is doing anything from a misconduct type of action. But it is distressing about these witnesses. They're emotionally charged. You know, I get it. But do we have any -- I mean, are we looking now at mostly police-type witnesses?

MS. JOBE: Yes, Your Honor.

THE COURT: Who is the witness that was going to come in that was ill today?

MS. JOBE: Tiffany Keats. She's the CPS investigater.

But when you've got, you know, Shayleen talking about medication, you've got the mom talking threats when there wasn't really threats, it was just a demand, and then you've got this witness, which frankly I was surprised to have her come out about the breaking of the arm thing, but I'm just concerned about this. So I would say you might tell this witness she's got to keep it -- she's got to toe the line here. Because if she doesn't, I'm going to have to really strongly consider what Ms. McNeill is asking me for.

MS. JOBE: I understand that. And we will lean more towards leading questions during the dangerous I guess shall you say subjects in order to try to avoid unexpected answers that we've admonished these people not to say.

- Q Do you have any training or experience in working in the Sex Abuse Juvenile Detail?
 - A I do.

- Q Okay. And what is that?
- A Throughout the years since I was assigned to the detail I've been to various forensic interview trainings, interview and interrogation schools, several classes in different states put on by different agencies, as far as investigating sex crimes, psychology of sexual deviance. I was able to attend the Dallas Conference on Child Abuse that the FBI hosts every year. That was in 2009, if memory serves.
- Q As part of your investigation and your training for sex abuse juvenile detective, does that include search warrants, executing search warrants and certain evidence to look for specific to these types of investigations?
 - A It does.
- Q All right. And were you working as a detective in the -- that detail on January 21st, 2014?
 - A I was.
- Q And were you asked to assist Detective Igor Dicaro in an investigation he was doing?
 - A Yes, I was.
- Q All right. And was that investigation -- well, where was the location you had to go for that investigation?
 - A Detective Dicaro told me that he had been a part of

interviews that had taken place in Boulder City and that based on those interviews he needed assistance going to Searchlight.

- Q All right. And was that under Las Vegas
 Metropolitan Police Department Event Number 140121-1194?
 - A Yeah. I believe that's correct.

- Q All right. And did you travel to Searchlight with Detective Dicaro?
- A I did. Based on the information that we were given we decided that we would need several detectives to go along. So Detective Kira [phonetic] and I accompanied Detective Dicaro to Searchlight.
- Q And while you were traveling to Searchlight was Detective Dicaro working on obtaining a search warrant?
- A When we were about halfway there, as we were talking about the case on the way there, he indicated that he would need to write a search warrant based on the information he had, or that he would have to do a telephonic search warrant. So we pulled off the side of the road and I started driving the car so that he could begin working on his search warrant while we were on the way to the residence.
- Q When you arrived to Searchlight did you immediately go to the residence, or did you go somewhere else?
- A No. We went to a gas station to meet uniformed patrol officers.
 - Q What was the reason for taking uniformed patrol

officers?

A It's a safety thing. Anytime you're doing suspect contacts and/or a search warrant it's always best practice to have uniformed officers there. It's a safety measure for detectives on scene for anybody in the residence, and then it just is a little bit better for us to have visibility of black-and-white marked units, uniformed officers so that there's no question that we are actually police.

Q All right. And when you got to Searchlight and met up with these uniformed officers did you all then proceed to 390 Hill Street in Searchlight, Clark County, Nevada?

A We did. We followed -- we were -- the three detectives were in one car, and we followed the black-and-whites to that residence.

Q All right. When you got to the residence did you encounter any individuals?

A Not immediately. The uniformed officers approached the door first, they knocked, they asked for the gentleman we were there to see. Someone came out -- a male came out. The officers took him into custody. There was some raised voices and yelling, and everyone appeared a little upset at that time.

Q All right. And who was the suspect you were there to see?

A We were there for Justin Langford.

- Q Who? Well, can you please point to the person and describe something they're wearing.
 - A The man in the tie and the white shirt.
- MR. BURTON: Your Honor, may the record reflect identification of the defendant?
- 10 THE COURT: The record will so reflect.
- 11 BY MR. BURTON:
- 12 Q Did you take a photograph of the defendant at that 13 time?
- 14 A Yes, I did.
- Showing you what's been admitted as State's

 16 Exhibit 43, do you recognize that photograph?
- 17 A Yes.

- Q Did you also at that time take a buccal swab of the defendant?

- 23 Q Describe what a buccal swab is, please.

- Q Ms. Sams, showing you what's been marked as State's Proposed Exhibit 5, do you recognize it?

- Q Tell the jury what you do with a buccal swab kit after you're done scraping the inside of somebody's mouth.
- Q We take one Q-Tip on the inside of each cheek. It goes into a little box. And the event number is put on there, placed into this envelope. It's sealed, sealed again, and it's impounded like the other -- well, actually this one is impounded a little different way, because sometimes they take it straight next door to the forensic lab, just the way it's set up. But it's impounded the same way, in a locked vault.
- Q Thank you. Were you wearing gloves when you took the buccal swab?
- A Yes.
- Q Were you wearing gloves when you searched the residence, 390 Hill Street?
- 17 A Yes.
 - Q Were the other -- you know, the detectives participating in the search warrant also [inaudible]?
- 20 A Yes.
 - Q Is that a policy and procedure that Las Vegas
 Metropolitan Police Department has?
- 23 A It is, yes.
- Q Why is that procedure in place?
- 25 A For two reasons, so we don't contaminate the scene,

so we don't get any contamination on us. Both reasons.

- A I was.
 - Q What was your role in that investigation?
 - A I was the primary detective assigned to the case.
- Q Were you at that time assigned to a specific detail as a detective?
- A Yes. I was assigned to a Sexual Abuse Juvenile Section of the Sex Crimes Division.
- Q Did you receive any training as a juvenile sex abuse or sex assault detective?
- A I did.
 - Q Describe some of that for the jury.
 - A Most of the training was on-the-job training, and it involved me shadowing the other detective. However, there was some specific training as to interviewing children [unintelligible] abused.
- Q Showing you what's been marked as State's Exhibit 42, do you recognize this as the calendar depicting
