ORDER DENYING MOTION TO CORRECT AND/OR MODIFY ILLEGAL SENTENCE

Before the Court is Petitioner KUPAA KEA's (hereinafter "Petitioner") Motion to Correct and/or Modify Illegal Sentence filed on February 4, 2014. On February 23, 2015, the State filed an Opposition to Motion to Correct and/or Modify Illegal Sentence. On March 20, 2015, Petitioner filed a Response to State's Opposition of Motion to Correct and/or Modify Illegal Sentence.

BACKGROUND

Petitioner seeks post-conviction relief from a judgment of conviction entered on June 5, 2012, pursuant to Petitioner's plea of guilty. *See* (Judgment of Conviction, p.1). Petitioner was convicted of two counts of battery with the use of a deadly weapon causing substantial bodily harm. *Id.* The Nevada Supreme Court entered an *Order of Affirmance* on February 13, 2013.

ARGUMENTS

Petitioner moves this Court to correct or modify his sentence. First, Petitioner moves for correction or modification of his sentence pursuant to NRS 62B.390(3), as Petitioner argues he was improperly convicted as an adult. *See* (Mot. to Correct and/or Modify, p.4). Second, Petitioner argues his sentence should be corrected or modified as Petitioner contends the crimes were incorrectly presented to the Court as an "ambush." *Id.* at p.10.

The State first argues Petitioner's *Motion* should be denied as his argument regarding correction or modification of sentence for being convicted as an adult fails. *See* (Opp. to Mot., p.2). Specifically, the State contends Petitioner's *Motion* is inappropriate as a motion to correct presupposes a valid conviction. *Id.* The State further argues there is no constitutional right to be tried as a juvenile. *Id.*

Second, the State argues Petitioner's claim based on the disputed ambush fails as Petitioner is disputing the details of the crime, rather than mistakes concerning the defendant's criminal history. *Id.* at p.2. Thus, the State argues Petitioner's *Motion* should be denied. *Id.*

DISCUSSION

The Court may consider a motion to modify sentence or motion to correct an illegal sentence in limited circumstances. *Edwards v. State*, 112 Nev. 704, 707, 918 P.2d 321, 323-324 (1996). A motion to modify a sentence is limited to sentences "based on mistaken assumption about a defendant's criminal record which work to the defendant's extreme detriment." *Id.* at 324. A motion to correct an illegal sentence addresses the facial legality of a sentence. *Id.* The facial legality of a sentence depends on: 1) whether the district court was without jurisdiction to impose a sentence; and, 2) whether the sentence imposed exceeds the statutory maximum. *Id.* However, a motion to correct an illegal sentence may not be used to challenge the validity of a judgment of conviction or to challenge any alleged errors that occurred either at trial or during sentencing. *Id.* A district court should summarily deny a motion to modify or a motion to correct an illegal sentence that raises claims outside the proper scope of said motions. *Id.* at 325 n.2.

Upon careful consideration of the moving papers the Court finds Petitioner's first claim for relief fails as it falls outside the proper scope of a motion to modify sentence or a motion to correct an illegal sentence. First, Petitioner's claim he was improperly convicted as an adult is outside the scope of a motion to modify a sentence as the claim is not based upon a mistaken assumption of Petitioner's criminal record. Second, Petitioner's claim falls outside the scope of a motion to correct an illegal sentence as said claim does not challenge the facial validity of the sentence; specifically,

Petitioner does not allege the Court lacked jurisdiction to impose the sentence, nor has Petitioner alleged the sentence exceeds the statutory maximum.

The Court also finds Petitioner's second claim, regarding the "ambush" theory, fails as it also falls outside the proper scope of a motion to modify or a motion to correct an illegal sentence. First, Petitioner's claim falls outside the scope of a motion to modify sentence as Petitioner does not argue the Court based its decision on a mistaken assumption of the Petitioner's criminal record. Edwards v. State, 112 Nev. at 707 (holding "[T]he district court has inherent authority to correct, vacate or modify a sentence that is based on a materially untrue assumption or mistake of fact that has worked to the extreme detriment of the defendant, but only if the mistaken sentence 'is the result of the sentencing judge's misapprehension of a defendant's criminal record." (emphasis added) (citing State v. Eighth Judicial Dist. In and For Clark County, 100 Nev. 90, 97, 677 P.2d 1044, 1048 (1984))). Second, Petitioner's claim regarding the ambush does not argue the sentence was facially illegal or beyond the parameters of the statutory maximum.

Accordingly, and good cause appearing, the Court's order is as follows:

IT IS HEREBY ORDERED Petitioner's Motion to Correct and/or Modify Illegal Sentence is DENIED.
