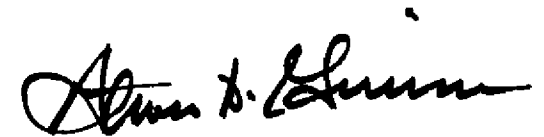

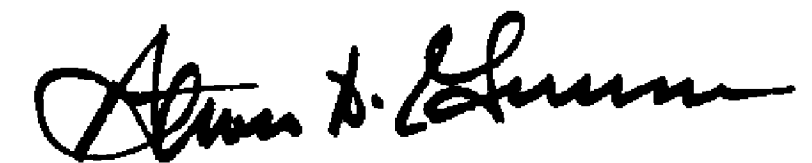

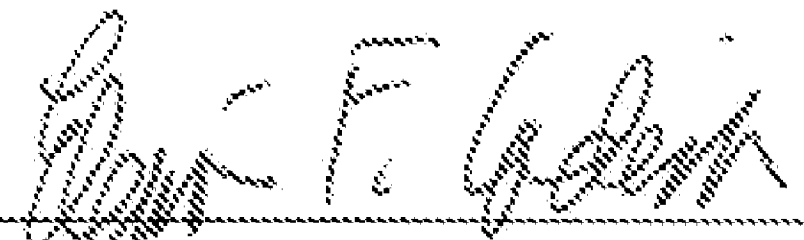
ORDER

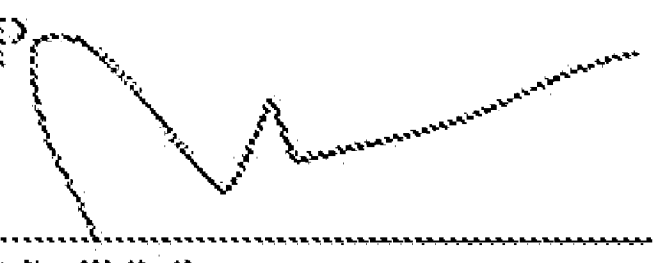
- 4/27/2016 order granting Plaintiff's motion for summary judgment
