4. That as of this date, Affiant has not received said transcripts.


5. That in addition, Affiant will be out of the jurisdiction from July 9, 2001 until July 20, 2001.

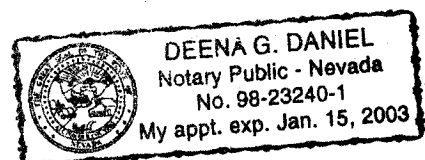
5. Therefore, Affiant requests a thirty (30) day extension of time through and including August 17, 2001 in which to file the Fast Track Statement in the instant case.
