

WRIT OF MANDAMUS


TO: The Honorable Jerry A. Wiese, Judge of the Eighth Judicial

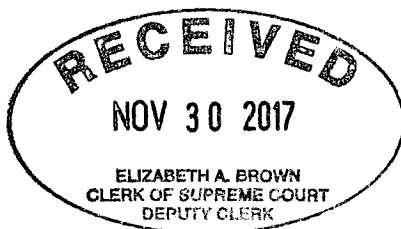
