On October 4, 2016 respondent Henderson Taxi filed an “Errata” to its opposition to appellant Michael Sargeant’s motion to stay the district court’s judgment pending the outcome of this appeal. The alleged purpose of that “Errata” was to “correct” counsel for Henderson Taxi’s allegedly “inadvertent” false characterization of this Court’s decision in *First 100, LLC v. Ragan*, Docket No. 68342, 2016 WL 45456783 (Order of 8/26/16). Henderson Taxi now explains that false representation by stating such representation was accurate in respect to *another* unpublished decision of this Court predating January 1, 2016 that under this Court’s rules, NRAP Rule 36(c), cannot be cited as precedent.
