#### **ACCESS AGREEMENT**

THIS ACCHES AGREEMENT (this "Agreement") is made and effective as of October \_\_\_\_\_ 2015, by and between MY Tupolo Entertainment, LLC, a Delaware limited liability company dba MY Entertainment ("Producer") and The Office of the Clark County Public Defender (the "Public Defender's Office").

- A. Producer is currently filming and producing a non-scripted television docu-series tentatively titled "Las Vegas Project" (the "Series") focused upon District Attorney Steve Wolfson and the deputy district attorneys and other professionals that work for the Clark County District Attorney's Office (the "District Attorney's Office").
  - B. The Series is currently intended for initial broadcast on the Discovery Network (the "Network").
- C. In conjunction with the Series, Producer desires to have access to Public Defender Philip J. Kohn and the deputy public defenders and other personnel of the Public Defender's Office and their activities and interface with the District Attorney's Office and that of their clients as each deputy public defender sees fit in conjunction with their defense of their individual clients (the "Public Defender's Activities"), on the terms and conditions provided herein.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which is hereby acknowledged, Producer and the Public Defender's Office hereby agree as follows:

- 1. Permission for Right of Access. The Public Defender's Office grants Producer the right to photograph and record, by means of any and all audio-visual media (including, without limitation, film, videotape and digitally) (the "Recordings") the deputy public defenders (and other personnel) and their clients and to portray the Public Defender's Activities for possible use in and in connection with the Series, and to broadcast, exhibit and otherwise exploit the Recordings (including, without limitation, all copyrights therein and all results, proceeds, modifications, extensions, sequels, spin-offs and other derivatives thereof) in any and all manner and media whatsoever, whether no known or hereafter devised throughout the universe in perpetuity.
- 2. <u>Public Defender's Control Over Activities</u>. The deputy public defenders shall have sole and complete control over the manner in which they operate and conduct the Public Defender's Activities. Producer's role in connection with the Series shall be solely to document the Public Defender's Activities as conducted by the deputy public defenders and other personnel. Producer shall have no role in the Public Defender's Activities, and is merely seeking the Permission granted by the Public Defender's Officer in Section 1 of this Agreement. For the avoidance of doubt, Producer and/or Network shall have sole ownership and control over all creative, production, business and financial elements pertaining to the Series and the Recordings.
  - 3. Public Defender's Right to Review and Approve Footage.
- (a) Producer agrees that, to the extent that any deputy public defender wishes to see the raw footage of any client communication, witness interrogation or gathering of evidence by the public defender which is recorded by the film crews of Producer ("Public Defender's Footage"), such raw footage will be made available to the deputy public defender for use in his or her preparation of the case. Producer agrees that, unless otherwise expressly directed to do so in writing by a deputy public defender, none of the Public Defender's Footage will be made available to the District Attorney's Office in conjunction with the preparation of the Series.
- (b) Producer agrees to provide the Public Defender's Office and applicable deputy public defender with the right to review any of the Public Defender's Pootage which Producer proposes to use in any episode of the Series to ensure that there are (i) no inadvertent admissions or statements against their client's interests, (ii) no defanatory remarks made against any person in the courtroom or otherwise involved in the case, or (iii) no statements or actions that could adversely affect the case or otherwise create potential liability for the Public Defender's Office, any deputy public defender, client or personnel. The Public Defender's Office shall have the right to approve (or disapprove) of the footage on the following conditions: (x) Producer will provide a copy of the proposed Public Defender's Footage which it proposes to use to the Public Defender's Office and applicable deputy public defender, or either of them, will have three (3) business days, excluding weekends and holidays, to either approve (or disapprove) the proposed Public Defender's Footage in writing. Any disapproval notice shall identify the specific scenes in the proposed Public Defender's Footage to which it objects and the specific reasons enumerated in items (i) through (iii) of Section 3(b) above for such disapproval. All other scenes in the proposed Public Defender's Footage to which neither the Public Defender's Office nor the applicable deputy public defender has objected shall be deemed approved and available for use by Producer. If neither the Public Defender's Office nor the applicable deputy public defender disapproves the proposed Public Defender's Footage within such three (3) business day period, such footage shall be deemed to have been approved by the Public Defender's Office and available for use by Producer.
