1 **MEMORANDUM OF POINTS AND AUTHORITIES**

2 On August 18, 2016, the undersigned counsel initiated the instant ap-
3 peal from the Judgment of Conviction in Eighth Judicial District Court case
4 number C-16-312887-1. On September 13, 2016, counsel ordered the tran-
5 scripts. The Opening Brief and Appendix are due to be filed on December 27,
6 2016.
