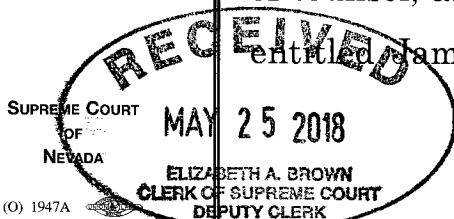
WRIT OF PROHIBITION
