In response to your letter dated February 22, 2016, regarding your untimely disclosure of trial witnesses in the above-referenced action, I cannot even begin to consider taking you up on your offer to allow me to depose these folks until I know to what it is they are going to testify at trial. In other words, you have not adequately disclosed the scope of their knowledge or the subject matter to which they may testify at trial, let alone why they were disclosed at this late date. If you would please provide me further and additional information as to the scope and nature of their testimony, I can be more responsive to your letter.

With that said, we do not intend to waive our Objection to your late disclosure of these witnesses by committing to taking their depositions now or at any time in the future. This letter is in response to your letter dated April 5, 2016, regarding the above-referenced action, as well as your Notice of Deposition for tomorrow for Michael Gros enclosed therewith. With all due respect, you are improperly attempting to try this case by ambush now and your letter and Notice of Deposition here are simply your latest effort in furtherance of as much. Although we also previously objected to as much – meaning to your Third and Fourth Supplements (as well as Pretrial Disclosures) pursuant to NRCP 16.1 and your unilateral Pretrial Memorandum (to which we also objected in our Pretrial Memorandum) -- this letter sets forth precisely our position on this issue and will be provided to the Judge before trial next week, too, as a supplement to our Pretrial Memorandum. Furthermore, the facts you are trying to gloss over here are not even in dispute between us and therefore important to resolution of this issue, i.e., your attempt to try this case by ambush now.

UNDISPUTED FACTS.

The Wynn alleges that Mr. LaBarbera executed twelve gaming markers on April 3, 2008, totaling in excess of \$1,000,000. The Wynn did not commence this action to collect on those markers, however, for almost six years and, therefore, it had to voluntarily dismiss all of its other claims in this action against Mr. LaBarbera because of the applicable statute of limitations, leaving for trial it's only remaining claim for breach of contract against him, i.e., the gaming markers. The Wynn only timely disclosed three witnesses in this case in its Initial Disclosures pursuant to NRCP 16.1 in October, 2014, to wit: Mr. LaBarbera, Barbara Conway and its PMK (generally). The Scheduling Order in this case was filed December 12, 2014, setting a discovery cutoff of July 8, 2015, which was not extended otherwise by stipulation or court order. The Wynn conducted Mr. LaBarbera's deposition in Rome, Italy, on June 11, 2015. The Wynn also

made two timely supplemental disclosures pursuant to NRCP 16.1 in June, 2015, but of documents only, not witnesses.

At his deposition in Rome, Italy, one month prior to the expiration of discovery in this case, Mr. LaBarbera testified that not only did he not recall signing the twelve markers alleged by the Wynn in this case, but he disavowed his signature on them altogether, albeit he would not say they were "forged" because he did not see anybody else sign them. In other words, the Wynn has known since then that Mr. LaBarbera could not authenticate its markers as genuine and, indeed, he emphatically denied numerous times under oath that it was his signature on them. Mr. LaBarbera also testified that he did not know he allegedly owed the Wynn in excess of \$1,000,000 pursuant to these markers until he was called by Mr. Pariente after returning to Italy from his trip to the Wynn in April, 2008, and Mr. Pariente informed him of as much. Ergo, you knew full well in June, 2015, that Mr. LaBarbera not only disputed the markers and his signature on them, but that he also believed that they were not authentic or genuine.

Incredibly enough, the Wynn then served its Third Supplemental Disclosures on our side in February of this year (as well as its Fourth Supplemental Disclosures late the next month, March, 2016) untimely disclosing seven more witnesses including another PMK "as to markers at issue, procedures and processes related to issuance of markers and gaming practices." (Again, the Wynn had only previously disclosed generally a PMK along with Mr. LaBarbera and Ms. Conway.) As you know, these proposed untimely witnesses now are Sandra Mele, Michael Gros, Scott Chang, Wail Nefei, Zuleima Shute, Alverna Duca and this PMK ("as to markers at The Wynn also listed these untimely disclosed witnesses in its Pretrial Memorandum and Pretrial Disclosures pursuant to NRCP 16.1. Mr. LaBarbera objected to the Wynn's Third and Fourth Supplement (as well as Pretrial Disclosures) pursuant to NRCP 16.1, and to the Wynn's Pretrial Memorandum, and confirmed as much in his Pretrial Memorandum with respect to all four of these pleadings that you are now using to try this case by ambush. As if this procedural process were proper on the part of the Wynn, Mr. Kircher then wrote me on February 22, 2016, offering to allow me to take the depositions of these witnesses less than two months before trial. I responded to Mr. Kircher on February 24, 2016, noting our objections to as much and, just as important, that the Wynn had even failed to disclose the substance of any testimony on the part of these witnesses and, therefore, we would not even know what to depose them on until such disclosure was received. To my knowledge, neither your office nor the Wynn ever responded to my letter back to Mr. Kircher dated February 24, 2016.

You now inform us that you want to take the deposition tomorrow of one of these witnesses untimely disclosed by the Wynn (Michael Gros), less than a week before trial no less, because he is supposedly going to have hernia surgery next week. Please be advised that I am not available for that deposition tomorrow as you have noticed it, nor will I be available for that deposition prior to trial (or any other deposition for that matter). Your untimely disclosure of these witnesses as well as noticing the deposition of this particular witness are patently delinquent, not in good faith, in violation of the applicable rules, intended to prejudice Mr. LaBarbera at trial, and possibly violative of NRCP 11.

MR. LABARBERA'S POSITION.

There are only three witnesses for this trial, to wit: Mr. LaBabera whose deposition testimony both of us will read into the record or to the jury, Ms. Conway whom you timely disclosed, and the Wynn's PMK in general (and not with respect to the specific subject matter of gaming markers). None of the other witnesses you have untimely named should be allowed to testify at trial as they were not timely or properly disclosed including proper disclosure of the subject matter of their proposed testimony in this case. You have known since June, 2015, about your need to disclose additional witnesses to authenticate the markers in question as genuine and you failed to timely or properly act. Your attempt to do so now is nothing less than "trial by ambush" for which you have no rationale or reasonable excuse.

With that said, I will have to you by the end of this week the designations of Mr. LaBarbera's deposition testimony I intend to read to the jury and/or offer into evidence at trial pursuant to NRCP 32. I respectfully suggest that, for reasons of economy, we agree to a few undisputed facts here, such as:

- 1) Mr. LaBarbera's age (63),
- 2) That he has been married for 40 years,
- 3) That he is a citizen and resident of Palermo, Italy,
- 4) That he cannot attend trial because of the bench warrant issued for his arrest by the Clark County District Attorney's Office, and
- 5) That he disavows his signature on the markers alleged by the Wynn in this case.

These facts are not disputed as you well know, and your attempt now to place at least the last fact into dispute here on the eve of trial is nothing more than trial by ambush and we intend to vigorously object to as much every chance we get, as well as to any such deposition testimony you also propose to use at trial (including Mr. Gros).

I trust your understand our position on this matter and, by way of disclosure again, we will be filing a supplement to our Pretrial Memorandum to provide a copy of this letter to the Judge to avoid any confusion or gamesmanship on these issues on the eve of trial.

Dear Jeff,

I write in response to your letter of April 5, 2016, regarding the above-referenced matter and the deposition of Michael Gros. To be clear, both Wynn and my office are prepared to work around your schedule in order to ensure that you, or someone from your office, may attend Mr. Gros' deposition. However, based upon your letter, it appears that you are unwilling to appear for Mr. Gros' deposition, regardless of the date or timing. Please advise me immediately if my understanding is in error. If I do not hear from you, Mr. Gros' deposition will go forward today at the time and location noticed.

Your client's unwillingness to participate in discovery and prepare for trial is not a new position. As you acknowledge, Wynn disclosed these additional witnesses (including Mr. Gros) almost two months ago, on February 10, 2016. On February 25, 2016, my office wrote to you providing additional details about these witnesses' knowledge and offering to make them available for deposition. Indeed, as this letter pointed out, you had already deposed at least one of the witnesses in the other case you are handling involving markers that went unpaid by an Italian gambler (and acquaintance of Mr. La Barbera) – *Wynn Las Vegas v. Cristiano Tofani*. Thus, you are more than familiar with the nature of this witnesses' knowledge. However, you refused Wynn's offer to depose these witnesses with more than two months left before the trial date.

As we have already shown, these witnesses were disclosed by Wynn because of Mr. La Barbera's seemingly ever-changing "defense" to Wynn's claims. Prior to the March 3, 2016, hearing on Wynn's Motions in Limine, your client appeared to be relying on the defense that he lacked capacity to sign the markers. However, any evidence regarding Mr. La Barbera's claimed intoxication or gambling addiction was excluded. Also excluded is any claim that Mr. La Barbera's signatures on the markers were forged. Notably, your client admits he signed the credit agreements but has stated that he "doesn't know" or "doesn't remember" if the signatures on his markers are his. However, Mr. La Barbera simultaneously rejects any contention that these signatures are

forged. With all due respect, it is your client that is engaging in gamesmanship – not Wynn. If Mr. La Barbera wants to dispute his signatures, then he bears the burden of proving his affirmative defense. Well aware that he cannot meet this burden (because the signatures are clearly his), Mr. La Barbera tries to pretend that the issue is one of "authentication." Nonsense.

Wynn is prepared to properly authenticate its business records with the testimony of its custodian of records. Nothing else is required. Moreover, the genuineness of Mr. La Barbera's signatures is conclusively proved by his responses to Wynn's Requests for Admissions wherein he admits that the signatures "appear to be his." As Wynn will demonstrate to the Court, there is not, nor can there be, any dispute about the admissibility or enforceability of Mr. La Barbera's gaming markers.

As you are aware, the overriding concern for a Court faced with a dispute about the timing of discovery disclosures is whether there has been any prejudice. Wynn has provided your office with every opportunity to depose these witnesses – including Mr. Gros. Because prejudice cannot be self-imposed, these witnesses must be permitted to testify.

THE COURT: I get that. But that's pretty much the only issue that they can hang their hat on. But, if in fact he's going to come in and say it's not my signature, it's a question of fact.

MR. KIRCHER: And he's taken inconsistent positions with that. In some of the requests he's said --

THE COURT: I understand.

MR. KIRCHER: -- that it appears to be his signature. At the deposition, all of

the sudden, he's like oh, this doesn't look like my signature. I can't say it was forged, but, you know. And that's -- I guess that is the issue that -- Your Honor hit the nail on the head.

THE COURT: All right. Opposition and countermotion.

MR. ALBREGTS: Yes, sir, Your Honor. Thank you.

Your Honor, you obviously read everything, but for the record I do my --

THE COURT: Being drunk doesn't fly. There's a case right on point in Nevada --

MR. ALBREGTS: Well it raises an issue --

THE COURT: -- that I know you're aware of.

MR. ALBREGTS: Yeah. Well, you know, I've had the pleasure and privilege, Your Honor, by way of a little bit of background, of litigating three of these with Mr. Kircher and Mr. Semenza. Judge Adair, on one of them, granted summary judgment, Judge Togliatti gave us a shot at jury trial in early December. The jury came back and threw out the largest marker.

The defenses are the same. What is notable in all three cases is an individual named Alex Pariente recruits these guys from Italy, they all three have gambling addictions, they come here, they sign the markers and Mr. Pariente is never produced in order to provide any evidence to rebut or oppose what they say.

I can go -- I wanted to make a record because these cases will play out later, Your Honor, in Italy under the Head Convention Treaty, as you might expect.

And in order --

THE COURT: Isn't this two-inch thick, your record?

MR. ALBREGTS: So stipulated, Your Honor. But if I may real briefly?

THE COURT: If this was Reno, you wouldn't even get oral argument.

MR. ALBREGTS: That's true. That's true, Your Honor.

THE COURT: So all right. As if there's something you need to add to this.

MR. ALBREGTS: But the reason the intoxication -- the only thing I need to add, Your Honor -- and I think it'd be best addressed through motions in limine.

Our defenses are basically fourfold and that is the one defense that appears not to be very well accepted here, is that the Wynn is using the affirmative -- or they're using the statute barring the affirmative defense of gambling, sickness, or addiction as a sword and a shield. It goes and recruits these guys. La Barbera is a guy who is certified and who would produce the report as being a gambling addict in Italy.

Again, you can address that by a motion in limine. But the most important thing is based on the lack -- on the intoxication, his lack of English -- and I can go to the depo transcript: Can you read English? No. Can you write English? No. I do not know these were checks. Nobody explained that to me. If he would have explained it to me, I would have got on the plane, went back to Sicily.

In fact, Mr. Semenza went through the exact admonition on the instrument about criminal penalties. He said if he understood that, he would have never signed them. So what the triable issue of fact we --

THE COURT: These are all self-serving statements.

MR. ALBREGTS: Mr. Pariente is not a --

THE COURT: The jury's going to hear.

MR. ALBREGTS: Right. Right, right, right, right, right. But I think, you know, when you don't produce Mr. Pariente and the only basis by which you consider what they have offered as evidence being the markers which are disputed as to whether

he signed them or not -- and he was not willing to say they were forgeries in his deposition, but he did emphatically say they weren't his signatures.

I think at that point in time his unopposed testimony provides a sufficient basis for you to grant summary judgment in his favor on the breach of contact claim. They don't even have an equitable claim for unjust enrichment here, Your Honor. This gentleman has testified and nobody's rebutted it that he didn't know what he was signing. They were not translated. He was intoxicated --

THE COURT: Well how can you --

MR. ALBREGTS: -- when they were signed.

THE COURT: Hey, how could you possibly -- who in the world could you get to say he didn't understand it except he's saying it. It's a question --

MR. ALBREGTS: Unless we --

THE COURT: -- of fact for the jury to believe or not believe.

MR. ALBREGTS: And I agree, Your Honor, but in answer to that --

THE COURT: Nobody can crawl into his brain.

MR. ALBREGTS: I agree, Your Honor.

THE COURT: Yet.

MR. ALBREGTS: But in answer to that question, Your Honor, Mr. Pariente, if they were to produce him -- who was with him as a host when he was supposedly signing this stuff, then they would have a genuine issue of fact. With Mr. La Barbera's testimony on its face, taken at face value, and it doesn't contradict itself, with respect, I think we're entitled to summary judgment.

I -- you know, and this case was filed two months before the six-year expiration of the statute of limitations. And simply because you consider the markers based on hearsay exception, business records exception, doesn't mean

they're authentic and genuine, which is also a question for the jury, as you have well pointed out.

THE COURT: Did you object in your 16.1 to their authenticity?

MR. ALBREGTS: I always preserve that objection in the jury case conference report, Your Honor.

THE COURT: Okay. All right.

MR. ALBREGTS: I'm glad --

THE COURT: Then you'll have to deal with that --

MR. ALBREGTS: I'm glad I've been teaching the kids to do that too.

THE COURT: Good.

MR. ALBREGTS: I apologize for interrupting.

THE COURT: Countermotion. On his countermotion for summary judgment, do you have anything to add?

MR. KIRCHER: You know, and -- you know, we have -- most of its laid down. I don't want to beat a dead horse, but the Pariente issue is they had the opportunity to subpoena and have this guy testify if they really believe it, which they didn't do. Number two -- and --

MR. ALBREGTS: He's in the Bahamas.

MR. KIRCHER: Right now I believe he's in Miami, but he -- you know, you can look him up by just doing a *Google* search. He was in the Bahamas, now I believe he's in Miami. You know, he's still working in the gaming industry. And even in his deposition testimony he says he barely saw Pariente throughout the trip. That's what he testified to. Pariente wasn't there forcing him to sign markers.

The second things is his language barrier, the law is clear in all -- pretty much all through the United States that the language barrier does not matter. If you sign a contact you're obligated to those terms. That would basically turn commercial instruments upside down because everybody's like oh, I didn't understand this contact. I didn't understand the terms, I couldn't read English. Well, you shouldn't have signed the contact unless you asked somebody to translate it.

And he testified throughout his deposition, for almost every document, he never asked one person to translate the document for him. So it -- the case law is clear that it's his -- there's no mistake on his part, there's no anything else, it's his burden to understand what he's -- what kind of contact he's entering into.

THE COURT: All right. Thank you. I'm denying the motion for summary judgment. I'm denying the countermotion for summary judgment.

The motion for summary judgment, as far as I can see there's only one real question of fact as I stated and that'll be -- that's certainly -- or easily is, regarding his questioning of whether or not the documents were actually signed by him.

And regarding the countermotion, there are an abundance of facts denying the countermotion. His -- the document -- he's right that these are contracts that he's signed. Nobody -- he's not saying somebody forced his hand to it. And his now saying he didn't understand what he was signing 20 times is going to be a question for the jury.






