MEMORANDUM OF POINTS AND AUTHORITIES

Real Parties in Interest move the Court for an extension of time to file their Answer to the writ petition.

Petitioners MDC Restaurants et al. filed their writ petition on September 20, 2016. On October 14, 2016, this Court ordered Real Parties in Interest to answer the petition within 30 days, or by Monday, November 14, 2016.

During the week of October 17, 2016, Counsel for Real Parties in Interest received requests from certain third parties asking assent to the submission of *amicus curiae* briefing in this matter. Each request was granted readily. Two *amici* have now filed their request to participate; at least one has made motion for an extension of time to file their papers until November 14, 2016, and the other is expected to do so as well.

In an effort to streamline the briefing process, avoid multiple briefs, and permit Real Parties in Interest to respond properly to the arguments of Petitioners and prospective *amici*, it is here requested that the Court extend the time for the filing of the Answer in this matter up to and including **November 30, 2016**.
