Appellant Jared Awerbach requests 14 days, until March 26,

Jared's appellate counsel submitted his response to the Court's

order on March 26 thinking that that was the due date under a

telephonic extension. (Filing Receipt, Ex. A.) We certainly intended to procure this brief extension and calendared the new due date accordingly. At the time, however, a key member of our staff—who would have ensured correct calendaring—was out of the office. We were also in the midst of a six-week jury trial in which the judge was requesting expedited submission of jury instructions and verdict forms. Focused on these issues, multiple attorneys assumed that someone else was arranging the telephonic extension, and when the "Order Granting Telephonic Extension" came through, multiple people assumed that someone had. It now appears that we made an honest mistake.

We sincerely appreciate the Court's patience and respectfully request the Court to file the response submitted on March 26. On an issue as important as appellate jurisdiction, Jared's submission is necessary to address the Court's concerns and aid in its ultimate determination.
