**MOTION FOR EXTENSION OF TIME TO FILE REPLY BRIEF**

Appellant Emilia Garcia requests 30 days, through June 3, 2019, to file her Appellant's Reply Brief. NRAP 31(b)(3). This is the first such motion.

The parties previously stipulated to extend the deadline pursuant to NRAP 31(b)(2). The brief was originally due April 3, 2019 and without the extension, would be due May 3, 2019, pursuant to the prior stipulation. No requests for extension have been denied or denied in part.

Additional time is necessary to complete the brief. Respondent's Answering Brief was 52 pages long and undersigned counsel needs additional time to refine arguments and reduce the length of the Reply to comply with NRAP 32(a)(7). During the thirty (30) day stipulated extension, the undersigned counsel was on the trial calendar for two civil jury trials, one of which started jury selection on April 15 and settled during plaintiff's case in chief. 


