## **MOTION FOR CONTINUANCE OF ORAL ARGUMENT**

Appellant Emilia Garcia requests a brief continuance of oral argument in this case, which has been set by this Court for December 12, 2019, at 11:30 am. This is the first such request.

14 Undersigned counsel in this case, Lee Roberts, will be arguing in this appeal 15 on behalf of Appellant Garcia. Mr. Roberts started *voir dire* on December 2 in a jury 16 trial before the Honorable Joanna Kishner, Department 31 of the Eighth Judicial 17 District, styled Brown v. GNL, Corp. and ThyssenKrupp Elevator Corp., Case No. A-16-739887-C. Trial is scheduled daily through December 20, 2019. 18

19 At the commencement of trial, Mr. Roberts informed the trial court of this 20 Nevada Supreme Court oral argument and requested that the jury trial be dark the morning of December 12, 2019. Judge Kishner was happy to accommodate this 21 request, and trial is not currently scheduled for the morning of December 12, 2019. 22

23 Unfortunately, there were unanticipated delays in jury selection in Case No. A-16-739887-C. Opening statements were scheduled for Tuesday, December 3, 2019, 24 but were delayed until today, Friday, December 6, 2019. We know we will lose one 25 26 juror on December 20 due to pre-paid travel and only have two alternates seated. Trial counsels for all parties are now becoming concerned that if trial is delayed into 27 Christmas week we will lose too many jurors to deliberate – potentially resulting in a

mistrial. Accordingly, I have agreed to ask this Court for a continuance of my oral
 argument in order to prevent further delays in the jury trial.

The undersigned counsel recognizes that proceedings in this Court take priority over District Court proceedings, and if a continuance would inconvenience or disrupt the Nevada Supreme Court in any way we are ready to proceed with oral argument as scheduled.
