Pursuant to NRAP 44 and NRS 30.130, please take notice that appellant Wells Fargo Bank, N.A., As Trustee On Behalf Of The Holders Of The Harborview Mortgage Loan Trust Mortgage Loan Pass-Through Certificates, Series 2006-12 is challenging the constitutionality of NRS 116.31162-116.311635 (2012). Appellant contends that certain provisions of these statutes governing notice of association foreclosure sales are unconstitutional

under the Due Process Clauses of the Fifth and Fourteenth Amendments and the Nevada Constitution.
