16	TONY HOBSON hereby moves for an enlargement of time to file his opening brief – to	
17	April 24, 2017.	
18	A. PROCEDURAL BACKGROUND	
19	The Opening Brief is currently due on March 20, 2017. A previous request for	
20	enlargement of time was granted owing to late receipt of transcripts on January 12, 2017, which	
21	were originally due on October 28, 2016.	
22	B. <u>JUSTIFICATION FOR MOTION</u>	
23	Counsel requested the entire court file the same day she filed the Notice of Appeal, and	
24	thought she had received the entire file from the court by January 13, 2017, the date the 1 <sup>st</sup>	
25	request for enlargement of time was filed. However, when she was going through the file, she	
26	noticed that some court documents listed on Odyssey were missing from the file she had received	
27	from the Court. Accordingly, she sent a letter to the court clerk again requesting a copy of the

entire court file. A copy of that letter which was sent on January 31, 2017, is attached. Counsel did not receive that file from the court clerk until the end of February.

In order to make sure that the file was complete, counsel had to prepare a table of contents of the Appendix (without page numbers) in order to sort through it and compare with the new documents just received to determine which ones needed to be added to the documents previously received. She also used that (partial) table of contents to compare with court documents on Odyssey to make sure that no court documents were missing. Counsel believes that some of the confusion regarding the court file stems from the fact that although the three co-defendants were tried together (until one entered a plea bargain), they were each assigned the same case number with different subsections.

In any case, counsel has checked and double checked, and the Appendix is now complete. Counsel must now bates number the Appendix and then add in the page and volume numbers to the Appendix table of contents which she already prepared, so that the Appendix can be sent out for copying and binding. Only then, can she begin reading the record with the ability to make notes of page and volume numbers where pertinent issues and facts are located. This case involves an Appendix which currently takes up 12 three-inch binders and which counsel anticipates will total over 4,000 pages in length (16 volumes). The trial was three weeks long. The facts revolve around convictions on 82 counts of robbery and related charges which took place at 14 different fast-food establishments – most of which also involve the issue of whether charges should stand for kidnapping of persons in the establishments who were moved from one room to another during the course of the robberies. That issue needs to be analyzed as to every single one of the victims for whom kidnapping was charged.

## C. CONCLUSION

The court rules provide counsel with approximately 120 days from the date that the notice of appeal is filed, to finalize the appendix and prepare the opening brief. If transcript requests are timely served shortly after the notice of appeal, as occurred in this case, counsel normally has 90 days after receipt of the transcripts to prepare the opening brief. Counsel previously only sought 60 days from the time the transcripts were received to prepare the opening brief. Owing

to the snafu with the court file, she must now request the additional approximately 30 days which is normally accorded by the rules from the time the transcripts are received. She contends that is a reasonable amount of time, especially given the length of the record and the sentence which exceeds 157 years, as well as issues which arose with obtaining the court file and the transcripts which were beyond her control.
