The Parties, by and through their undersigned counsel, stipulate and agree as follows:

1. On October 5, 2016, Elaine Wynn filed a Petition for Writ of Prohibition or, in the Alternative, Mandamus (the “Petition”).

2. In the Petition, Ms. Wynn seeks protection from disclosure of certain information she claims to be protected under the Dodd-Frank Wall Street Reform and Consumer Protection Act and the Sarbanes-Oxley Act of 2002.

3. On October 20, 2016, Ms. Wynn filed a Motion to Extend District Court’s Stay Pending Writ Petition (“Motion to Extend Stay”).

4. The Aruze Parties have an interest in responding to the Motion to Extend Stay, which, if granted, could further extend the June 23, 2016 stay of discovery imposed by the district court pending the district court’s disposition of Wynn Resorts, Limited’s Motion to Disqualify the Quinn Emanuel law firm which represents Ms. Wynn.

5. The parties hereby stipulate that the Aruze Parties shall be permitted to file in response to the Motion to Extend Stay.

6. The Parties reserve, and in no way waive, their respective rights as to any request by the Aruze Parties for further involvement concerning the Petition.
