**MOTION FOR EXTENSION TO FILE PETITIONER'S REPLY BRIEF**

Petitioner requests 30 days, through January 27, 2017, to file her reply brief. NRAP 31(b)(3). This is the first such request. Without an extension, the brief would be due December 28, 2016.

For several reasons, more time is necessary to complete the reply brief. The important issues in the petition, as discussed in the answering brief, call for a thorough reply. Wynn Resorts, too, received an extension to file its answer. And because most aspects of the district-court proceedings have not been stayed, the parties have had to focus on substantial motion practice, hearing preparation, deposition scheduling,

and other matters. In addition, anticipated district-court rulings over the next few weeks may be relevant to issues raised in Wynn Resorts' answer. Members of the appellate team have also been dealing with personal and family medical issues.

Finally, although counsel understand that their caseload does not ordinarily factor into whether to grant an extension, several out-of-state depositions in another case have prevented Dan Polsenberg from completing the petition. Because those depositions take up most of the first half of January, counsel request the customary 30-day extension, rather than a shorter one.
