

Pursuant to Nevada Rule of Appellate Procedure 34(a), Respondent, LAURA ANDERSON, by and through her counsel of record, Kathleen Bliss, of Kathleen Bliss Law PLLC, hereby requests that the Court postpone the oral argument presently set for April 18, 2018, and reset it to a later date and time convenient for this Court, but no sooner than 60 days from the current setting.

Counsel for Respondent has conferred with counsel for Appellant Las Vegas Metropolitan Police Department, Nick Crosby, Esq. Mr. Crosby has no objection to the requested continuance.
