MEMORANDUM

I, CHARLES THOMAN, am a duly licensed attorney in the State of Nevada and am employed by the Clark County District Attorney's Office.

Respondent's Answering Brief is currently due July 13, 2017. This is an appeal from a Judgment of Conviction. This Court may extend the time to file a Fast Track Response upon a showing of extreme need or merit. NRAP 3C(i)(2)(B).

The State herein makes its second request for an enlargement of time. The State requests thirty (30) days from July 13, 2017, within which to file Respondent's Fast Track Response. If granted, the new filing date for the Respondent's Fast Track Response would be August 14, 2017.

Appellant filed four Motions for Extension prior to filing his Fast Track Statement on May 24, 2017, with an accompanying appendix of nearly 800 pages.
