## APPELLANT LIPSITZ'S MOTION FOR ONE-WEEK EXTENSION OF TIME TO FILE APPELLANT'S OPENING BRIEF

COMES NOW Appellant LIPSITZ, by and through AMY A FELICIANO, ESQ., and moves this Honorable Court to grant a one-week extension of time to file Appellant Lipsitz's Opening Brief from the present due date of November 20, 2017, to November 27, 2017. NRAP 31(b)(3)(A)(i).

LIPSITZ requests the one-week extension due to Feliciano's serious medical condition. Feliciano's medical condition(s) has rapidly progressed since diagnosis in July/August 2017. As a result, Feliciano experiences periods of time

and/or days wherein Feliciano loses the use of her motor controls and experiences extreme weakness in her limbs.

Accordingly, she is then physically incapable of performing the physical activity required to prepare the opening brief in the instant case.

Feliciano recently had further diagnostic testing, which resulted in an additional diagnosis of a potentially fatal comorbid medical condition. This comorbid diagnosis has resulted in Feliciano having to devote, unexpectedly, significant time and attention to the coordination of follow-up medical visits, further diagnostic testing, and making all provisions for her treatment protocol. Id.

Feliciano has previously moved twice for an extension of time to file Lipsitz's Opening Brief. Both requests were granted. Id. at (b)(3)(A)(iv)-(v). Lipsitz's Opening Brief was originally due June 30, 2017. Id. at (b)(3)(A)(i).

Based on the above, Lipsitz hereby requests that this Honorable Court grant his Motion and order that Appellant's Opening Brief's due date be extended to November 27, 2017.
