ORDER REGARDING TRANSCRIPTS

Appellant served a transcript request form on court recorders Victoria Boyd and Cheryl Carpenter on April 10, 2017.¹ In a motion filed with this court on July 27, 2017, counsel for appellant represents that she has not yet received the transcripts requested from Ms. Boyd and Ms. Carpenter for proceedings conducted on numerous dates. To date, neither Ms. Boyd nor Ms. Carpenter has filed the notice of delivery required by NRAP 9(c)(2). A copy of the transcript request form is attached.²

Ms. Boyd and Ms. Carpenter shall have 20 days from the date of this order to: (1) file and deliver the requested transcripts as required by NRAP 9(c)(1)(A) and (2) file with this court the notice required by NRAP 9(c)(2). If either Ms. Boyd or Ms. Carpenter needs an extension of time, a motion as provided in NRAP 9(c)(4) must be filed within the same time


