DECLARATION OF SHARON G. DICKINSON

- 1. I am an attorney licensed to practice law in the State of Nevada; I am a deputy public defender assigned to handle the appeal of this matter; I am familiar with the procedural history of this case.
- One 01/17/18, this Court issued an Order denying my request for an 11 day extension but allowed me to file the Opening Brief on Friday, 01/19/18 - tomorrow. When I filed the motion for an extension on 01/09/18 I was in good health. On Sunday, 01/14/18, I fell ill and spent almost the entire day off my feet. On Monday I thought I was getting better but then took a sick day on Tuesday 01/16/18. The symptoms I am experience lead me to believe I have an ear infection, sinus infection, sore throat, and/or a virus.
