

17 date of the appellant's request.

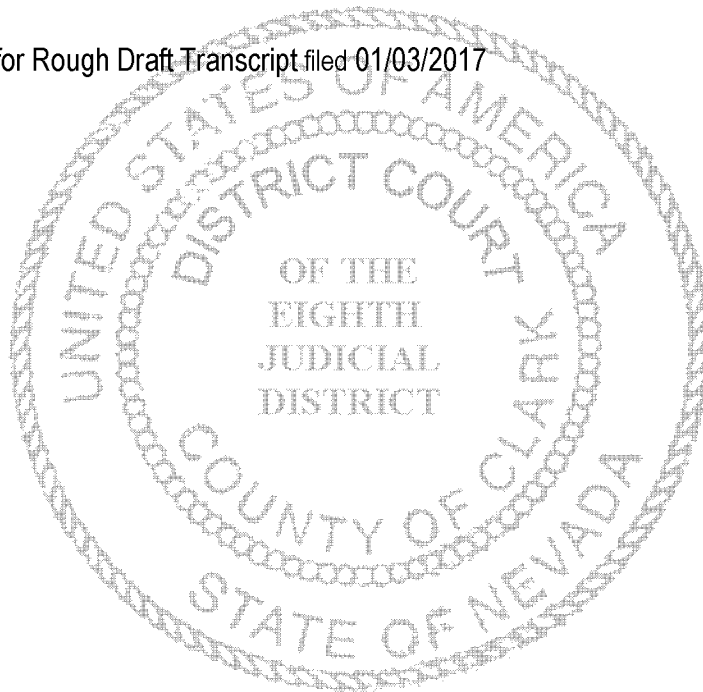
