





- This Court, having considered the Defendant's Motion for Stay and Plaintiff's Opposition GRANTS IN PART and DENIES IN PART Defendant's Motion. NRS 41.660 provides for the mandatory stay of discovery pending disposition of the appeal and therefore the Defendant's Motion to Stay is GRANTED as to discovery. When considering the factors for a stay of the entire litigation, in this Court's view none favor Defendants. First, the object of the appeal will no be defeated. Next, there is no irreparable injury because litigation expenses do not constitute irreparable harm. Here, if the Supreme Court agrees with Defendant's they would recover reasonable costs and attorney's fees from Plaintiff based upon NRS 41.670.
